## PAYMENT

HÅG® accepts all major credit cards, company checks, cash, and terms payment for approved accounts. Credit card payments are subject to a 3% service charge. A \$35 fee will be charged for returned checks.

## TERMS

Standard terms are net 30 days from date of invoice. Please respect these terms in order to protect your competitive pricing. Credit terms may be changed or canceled at HÅG®'s discretion.

1. All new accounts are required to remit a 50% deposit of the initial order's total dollar value prior to the order entry and the balance must be paid at the time of pick up or release to common carrier. A line of credit may be established upon acceptance of satisfactory references and the completion and signing of credit application.
2. The customer will be liable for any cost incurred in attempting collection of past due amounts, including attorney fees, whether or not a lawsuit is filed. Past due accounts are subject to a 2% per month (24% per annum) late charge, or maximum amount permitted under local law, for each thirty days, or part thereof that the outstanding balance remains unpaid beyond the thirtieth day after invoice date. Withholding of payments, because of carrier damages, shortages or other disputes is illegal and subject to charges.
3. Orders delayed due to credit hold will be rescheduled for production once the order has been credit released. A new lead time will be given at that time. Please contact Customer Care to coordinate details.

## PRICES

All prices are suggested retail and are subject to change without notice. We make every effort to notify all customers of such changes. Prices in effect at the time of shipment will prevail. Please refer to our online price book for the latest changes including product drops and additions.

## ORDER ACKNOWLEDGMENT

Unless there is a credit issue or you are otherwise contacted, an order acknowledgment will be emailed to you once the order is approved by our

Planning department. The order acknowledgment will confirm quantities, items ordered, and prices effective at the time of the order acceptance (prices may vary from the published list). Be sure to read these acknowledgments and contact us immediately if incorrect.

## SHIPPING

Complete and specific instructions for shipping should be given at the time an order is placed. Orders that do not have specific instructions will be routed by the best method of shipment in accordance with the judgment of our traffic department. Any changes to shipping instructions must be submitted to our office in writing. Standard shipments are made via common carrier unless otherwise requested by the customer. Special routing requests made by the customer or the consignee may result in additional charges. Standard deliveries are dock-to-dock and are scheduled to occur Monday through Friday between 8:00 a.m. to 4:30 p.m. PST.

HÅG® reserves the right to charge the customer for non-standard customer delivery requirements that may include delivery appointments, drop shipments, inside deliveries, residential, limited access, or requests for trucks with lift gates. Additional charges may also be incurred for redeliveries or re-consignments if the initial delivery cannot be made for any reason. HÅG® will not be held responsible for issues or costs to the customer arising from carrier transit delays or missed appointments. # Condition of Sale

## WILL CALL

Will Call orders will be scheduled and manufactured based on Customer requested completion dates. Customers will receive a notification once the Will Call order is ready to be picked up. Customers will have five (5) business days to pick up the order. If the order is not picked up within this time frame, HÅG® will ship the order to an offsite storage facility and will invoice the Customer. The following storage fees will be invoiced to the Customer:

- 1- 50 chairs: \$25/day
- 51-100 chairs: \$50/day
- 101+ chairs: \$75/day

## FREIGHT DAMAGE OR SHORTAGE

Before accepting a shipment from the carrier, check the boxes for visible damages. If a shortage or damage occurs during transit, it should be noted on the freight bill of lading at the time of delivery, and a claim filed within seven days from receipt of product. If concealed damage is discovered after delivery, request inspection from the delivering carrier IMMEDIATELY and

save all packing materials until inspection is made. Contact Customer Care as soon as possible to report damage or shortage.

For all Will Call orders, make sure to inspect merchandise thoroughly. HÅG® will not be liable for any damage or shortage to merchandise after it has been signed for at our dock. HÅG® will not be liable for any installation costs that result from freight damage.

## CANCELLATIONS & RETURNS

Due to immediate production scheduling, orders that have entered any stage of production cannot be canceled. All HÅG® chairs are made-to-order, custom designed chairs and are not "off the shelf". Requests for cancellation are not accepted until confirmed by HÅG®. Product may only be returned after receiving a Return Merchandise Authorization number from HÅG®. Returns are subject to a restocking charge equivalent to 35% of the net order plus freight. Unauthorized returns will be refused.

## REPLACEMENT PARTS

When ordering a replacement part submit a warranty request through our website by navigating to the warranty page and selecting the Warranty Request Form. As a helpful tip, have your HÅG® Sales Order number available and please reference your instructions sheet to properly identify the correct part for your HÅG® product.

Replacement parts are shipped within 48 hours from time of request. HÅG® does not reimburse for labor and installation costs related to warranty replacements. Replacement parts needed to repair freight damage can be granted only if the request is received within five business days of receipt of the merchandise.

## Dimensions

Outside Width (W) - Distance measured at widest edges of chair.

Outside Depth (D) - With the outside back of chair against wall, the distance from the wall to the front edge of seat.

Outside Height (H) - Distance from floor to highest point of back.

Seat Width (SW) - Distance measured at narrowest point of seat's side edges.

Seat Depth (SD) - Distance measured using the BIFMA CMD (Chair Measuring Device) from the most prominent point of the lumbar to the front edge of the seat.

Seat Height (SH) - Distance measured using the BIFMA CMD (Chair Measuring Device) from the floor to the bottom of the device on the front edge of the seat. The CMD weighs 100 lbs.

Back Width (BW) - Distance measured at narrowest point of back's side edges.

Back Height (BH) - Distance measured from inside edge of rear seat to top edge of back.

Inside Arm Width - Distance between arms, typically measured from midpoint.

Arm Height - Measured from the floor to top edge of arm.

## TO PLACE AN ORDER

Specify complete model number, frame or plastic color, fabric pattern and color, quantity, ship-to address, payment method, and purchase order number. In the event that an error is made in production of the chair, the hard copy of the purchase order will be used as the resolution document.

## ORDER ACKNOWLEDGMENT

Unless there is a credit issue or you are otherwise contacted, an order acknowledgment will be sent once the order is released from our Purchasing department. It will be faxed or emailed to you to confirm quantities, items ordered, and prices effective at the time of the order acceptance (prices may vary from the published list). Be sure to read these acknowledgments and contact us immediately if incorrect.

## SHIPMENT NOTIFICATION

Upon shipment of an order a shipment notification will be emailed with carrier information.

# Lead Time

HÅG® intends to have all approved orders ready for shipment within the below lead times. However, there may be delays due to causes beyond our control. Orders received after noon PST will be considered as having been received the following day. Credit must be cleared before processing. HÅG® is not responsible for late deliveries from freight carriers.

## LEAD TIMES

1 Day ExpressShip.

5 Business Days ExpressShip includes all series and new products for the following fabric cards: Breeze, Signature, Vivid, Momentum Swift and Highlands L3.

Please specify "5 Day ExpressShip" on a separate purchase order to ensure proper handling and delivery time. DO NOT COMBINE with any other purchase order. In the event that a purchase order is not marked, order will be scheduled per our standard lead time below.

Standard 10-Day Lead Time includes all series. Excluding new products for the following textiles: cards including Breeze 2.0, Nautilus, Signature, Highlands L3 and Vivid. Supplier cards including Momentum Swift 2.0 and Performance 4.0, Green Hides Sierra L4, Maharam M Series, Stinson Fresh Energy and Ultrafabrics Impress the Senses.

Standard 15-Day Lead Time includes all series, all fabrics for the Standard 10 Day Lead Time plus Green Hides L5 Lena and graded-in textiles.

# Packaging Codes

## HOW TO SPECIFY

HÅG® offers several packaging methods for most models. Please note not all

packaging codes are available for each model. Reference the price book page for the model in question to view the packaging methods available. All available packaging methods and their corresponding prices can be found at the top of the price book page.

After determining the appropriate packaging method, please add the packaging code to the model nomenclature of the model as it appears on your purchase order. Example: 1725-M1-A4-101-AB.

AB – Assembled in Bag for Will Call and Blanket Wrapped

The chair will be fully assembled and covered with a clear plastic bag for protection from dust. Chairs shipping via blanket wrap carrier will be produced with packing method "AB" as the chairs will be picked up at the dock fully assembled in the will call area.

PAC – Partially Assembled in Carton

The chair will be produced and packed partially assembled typically with seat and back separated, and arms and controls pre-assembled in a shipping carton. Specially designed spacers are used to position all chairs in the carton and to prevent freight damage.

BAC – Back Assembled in Carton

The chair will be fully assembled with exception of the base, gas lift and casters that are packed into a specially designed carton for this hardware. The chair may be removed, casters placed in the base, gas lift placed in the base and the remaining chair set on top of the cylinder. No tools are required.

AC – Assembled in Carton

The chair will be fully assembled and placed in a carton. This applies primarily to guest chairs that must ship fully assembled to accommodate chair design. Some guest chairs ship with multiple chairs in one carton.

# Upholstery Selection

## FABRICS

Choose from thousands of different fabrics, comprised of varying price grades offered through multiple fabric cards. If you still can't find what you are looking for, you may choose from any of the textiles offered by one of our textile partners.

## LEATHER

HÅG® offers three grades of leather. All L3 and L4 are upholstered with leather on the seating surface and vinyl on the back and side boxing. L5 is an all-leather cover. A COL (Customer's Own Leather) program is available.

L3 is a glove-soft, top grain European hide, available in Black.

L4 is a glove-soft, top grain Italian cowhide leather.

L5 is a luxurious Italian full-grain, semi-aniline dye leather with a soft hand and smooth supple surface with even coloration throughout the entire hide.

## FABRIC ORIENTATION

In order to offer optimal customization with our upholstery, customers must indicate a railroad orientation on a purchase order. Fabric manufacturers suggest within the specifications if a fabric pattern is recommended for railroad orientation.

Railroad or horizontal orientation requires more fabric than vertical orientation. When railroad orientation is requested, the fabric grade will be increased by one grade to compensate for any additional fabric. Please indicate railroad orientation if this is desired on a purchase order. The order will be handled as a special, and the railroad orientation will be executed. Please contact your

Customer Care Representative if you have questions about railroad orientation.

### ORDERING INSTRUCTIONS

Contact Customer Care for inquiries regarding COM/COL or follow the instructions below to assure the best results to produce your COM/COL order.

Complete HÅG® COM/COL form (see opposite page or download from website) and send it to HÅG® along with a fabric sample.

All COM/COL fabrics must be approved by HÅG® and will not be scheduled for production until the entire yardage/square footage requirements have been received. Approval can be completed by HÅG® in 72 hours. HÅG® will not return any excess COM/COL material. After 60 days from when the order ships, any excess COM/COL material will be recycled.

For non-directional, plain, solid colors or non-patterned fabrics, please follow COM yardage requirements as specified under each individual model number in our price list. For fabrics which require special application or direction, please attach a sample of the COM fabric to our COM form.

Include all information and return to HÅG® at address shown below. All COM textiles received at HÅG® must be clearly marked with customer's name, purchase order number, HÅG® sales order number (if available) and any special instructions for application of textile.

### NOTES

1. COM/COL EXCESS YARDAGE - HÅG® is not responsible for yardage submitted to HÅG® beyond the required amount. Excess COM/COL materials will be discarded at the discretion of HÅG® unless otherwise instructed by the customer at the time of order placement. If a customer requires the COM/COL excess yardage returned, they must contact Sales Support before order placement to make return COM/COL arrangements. The customer will be responsible for all COM/COL return delivery charges.

2. The yardage figures shown throughout the price list are estimates only. Calculations are based on 54" wide material with no repeat and cut in the woven way cutting direction for a single chair. For specific yardage based on width of material, chair model, and quantity, please contact Sales Support.

3. For large quantity orders please contact Sales Support for more precise yardage requirement. Actual yardage requirement per chair often decreases with larger orders.

4. To calculate COM yardage, use the chart below as a guide and add appropriate amounts to the generic yardage requirements listed in the pricer.

5. COL: Leather quality can vary depending on the size of the hides. Larger hides (50 to 60 sq. ft.) tend to be higher quality and yield. Smaller hides (40 to 50 sq. ft.) tend to have more quality issues that may cause smaller yields, requiring the need for additional hides to be ordered.

6. For all COL orders, HÅG® cannot take responsibility for the need to order additional COL due to quality issues and related small material yields.





# CAL TB 133 Fire Code

HÅG®'s entire line of office seating meets California Technical Bulletin 117-2013 (CAL TB 117-2013) which has been in effect since January 1, 2021. This is a standard by which upholstered furniture has been tested for approval to meet a minimum fire standard. HÅG®'s standard product is not designed to meet California Technical Bulletin 133. However, upon special request, most HÅG® products can be manufactured to meet the California Technical Bulletin 133 (CAL TB 133).

## CAL TB 133

CAL TB 133 is the standard of furniture flammability required by the California Bureau of Home Furnishings and Thermal Insulation for furniture used in public buildings. New requirements proposed for furniture used in public buildings include: healthcare facilities, convalescent homes, public assembly areas of hotels and motels, hospitals, board and care homes, stadiums, licensed child care facilities, prisons and jails.

## CAL TB 133 TEST

CAL TB 133 is a full-scale fire test for furniture manufactured for use in public buildings. The standards do not specify how to construct furniture, but only how it should perform when tested by the following procedures: A finished piece of furniture, never single components, is placed in a 10' x 12' x 8' chamber and is tested by applying a gas flame for 80 seconds. Then measurements are taken for the rate and amount of heat generated, temperature of the test room while furniture is burning, smoke capacity, amount of carbon monoxide generated and mass loss of the furniture for one hour or until the fire is completely extinguished.

A solution to pass this fire standard test is to sandwich a fire blocking liner between the foam and fabric of our chairs. This liner acts as a "fire extinguisher" by smothering the flame. As a response to CAL TB 133, and in order to meet customers' needs, 9to5 Seating has designed a variety of models and fabrics that can be combined to meet this new standard.

## CAL 133 MODELS

The following models when combined with approved textiles and blocker meet the CAL 133 standard.

## COM CAL TB 133

COM compliance for CAL 133 models listed above can be determined by specifying upholstery with the exact characteristics as approved fabrics or by conducting a full chair burn test. The non-discountable test fee for each chair-fabric combination is \$500 net.

## CAL TB 133 UPCHARGE

- 1 - 49 chairs: \$100 List upcharge per seat
- 50+ chairs: \$50 List upcharge per seat

## TO ORDER CAL TB 133

Clearly specify CAL TB 133 on order, choose your desired fabric, from options above, then add the indicated amount above to the standard list price. Standard lead times apply.

## TO CHECK PURCHASED SEATING FOR CAL 133

To determine whether your chair meets CAL TB 133, or to check an order you have recently received, check the bottom of the chair seat pan for the label shown below. If your chair does not show this tag below, then your chair does NOT meet CAL TB 133.


## Dual Tone Options

## Custom Embroidery Form

Custom embroidery is a great way to display your company logo on upholstered chair backs. Embroidery can be done in multiple colors, shapes and sizes to suit your needs for a very reasonable cost and lead time. To obtain a quote for embroidered upholstery, please fill out the adjacent form as completely as possible. You will need a graphic file, preferable in AI, EPS or other graphic format. Generally, higher resolution art (greater than 300 dpi) will be easier to work with. There will be a set-up charge to create a digitized file if you do not have one available. We will also need a PMS color number for each color thread required. HÅG® is not responsible for poorly digitized files or graphic files from the requestor. Embroidery will always look best on strong, closely knit fabrics or vinyl. It is best to always get a sample for approval before placing the full production order.




# BIFMA Ultimate Test for Fit (UTFF)

## ERGONOMICS - THE WORK CHAIR

The Business and Institutional Furniture Manufacturer's Association (BIFMA) has developed the following guidelines for UTFF. Parenthetical numbers following each item indicate corresponding subdivisions in the guidelines.

### SEAT HEIGHT (7.1)

Users should be able to sit with their feet comfortably on the floor or footrest without undue pressure on the underside of the thighs. The thigh-to-torso angle should not be less than 90°.

### SEAT DEPTH (7.2)

Users should be able to sit in the chair without undue pressure against the back of the knees, their back properly supported by the backrest and with adequate buttock and thigh support.

### SEAT WIDTH (7.3)

The seat should be wider than the hip breadth of the user with allowance for movement and clothing. The seat width should not limit the ability to use the armrests comfortably.

### SEAT PAN ANGLE (7.4)

This should allow users to support their feet on the floor or footrest. They should not cause the user's torso-to-thigh angle to be less than 90°. Forward seat pan angles should not cause users to shift excessive weight to their feet or experience the sensation of sliding out of the chair.

## BACK SUPPORT (7.5)

### SEAT BACKREST HEIGHT (7.5.1)

All backrests should provide adequate support and buttocks clearance. For tasks requiring upper body mobility, the backrest should not interfere with the user's movement. For users who prefer reclining postures or greater upper back support, the back height should provide support for the shoulder blades.

### BACKREST WIDTH (7.5.2)

The width of the backrest should provide adequate support for the curvature of the user's back without causing localized pressure points.

### LUMBAR SUPPORT (7.5.3)

The height and shape of the lumbar should coincide with the lumbar curve ("the small") of the user's back. The support should be firm, but not cause localized pressure points.

### LUMBAR SUPPORT (7.5.3)

The height and shape of the lumbar should coincide with the lumbar curve ("the small") of the user's back. The support should be firm, but not cause localized pressure points.

### MOVEMENTS OF THE SEAT PAN AND BACK SUPPORT (7.6)

The user should be able to sit in a position where the torso-to-thigh angle is equal to or greater than 90°. The seat and backrest angles should accommodate the varying postures assumed by the user throughout the day.

## ARM SUPPORT (7.7)

### ARMREST HEIGHT (7.7.1)

This should allow users to sit in a variety of postures while supporting their forearms and/or elbows in a manner that avoids lifting the shoulders (armrests too high) or leaning to the side to reach the armrest (armrests too low). The armrest height should allow accessibility to, and performance of, tasks.

### ARMREST LENGTH (7.7.2)

The length of the armrest should allow users to sit close enough to the work surface to perform their tasks while maintaining contact with the backrest.

### INSIDE DISTANCE BETWEEN ARMRESTS (7.7.3)

Armrests should allow users to sit in a variety of postures while supporting their forearms in a manner that avoids lifting the shoulders and/or excessive outward positioning of the elbows. Armrests should allow accessibility to, and performance of, tasks. The inside distance between the armrests should allow the user to enter and exit the chair easily. The hips should comfortably fit between the armrests or supports.


## CARE AND MAINTENANCE

- Ensure the gas cylinder is inserted into the control firmly. Improper connection may cause wobbling.
- Choose correct casters for different floor surfaces. We suggest choosing hard floor casters for tile or concrete surfaces.
- For drafting stool use, we recommend self-locking casters for hard floors. See Caster Guide for more details.
- Do not stand on foot ring.
- Do not sit on any part of the chair except the seat. Do not sit on arms or backrest.
- To avoid chair collapse, do not remove knobs or screws.
- Properly dispose of packing materials. Do not use plastic as head covering. It may cause suffocation.
- If any parts are missing, broken, damaged or worn, do not use the chair until repairs are made using factory-authorized parts.
- Do not attempt to make any alterations to chair.
- Do not use chair on uneven floor surfaces.
- Do not drape coats or sweaters on back of chairs with casters. Hanging fabric may suddenly stop casters from rolling.
- Do not use excessive speed when moving the chair with casters while seated.
- Do not overexert the functions of a chair which are only to be used under normal conditions.
- Do not stand on and/or use this chair as a stepladder. Use this product only for seating one person at a time.
- Do not use this chair unless all bolts, screws and knobs are firmly secured.

### CHECK THE FOLLOWING AT 4 MONTH INTERVALS:

- All exposed fasteners should be checked and any loose fasteners tightened. Use appropriate tools. Replace any fasteners that appear to be damaged in any way.
- The chair mechanism should be checked for any looseness, excessive wear or signs of damage. Immediately remove the chair from service if any damage or failure is found.
- The base and casters should be checked for any signs of excessive wear or failure. Immediately replace any parts that show such wear or failure.

However, the company does not warrant leather against routine scratching and scuffing, as all leather is subject to minor blemishes during use. COM and COL are not warranted.
