### Product description:

The RH Logic 300 family offers a range of ergonomic office chairs with medium backs, each designed to provide optimal comfort and support. Standard features include castors for soft floors and a base in silver aluminum. These chairs can be customized with various options and accessories to suit individual preferences.

All models feature a frictionless tilt mechanism that is infinitely adjustable and can be locked into the desired position. This encourages active seating, with the option to work with the tilt open. Additionally, the backrest angle is separately adjustable to provide support in any position.

The RH Logic 300 Comfort variant includes extra padding for improved ventilation, while the RH Logic 300 Elegance is equipped with an upholstered back shell for added style and comfort. The RH Logic 300 Elite model is designed for 24/7 use and features 20 mm extra foam in the seat and back pad for enhanced comfort during extended periods of sitting. Adjustment controls are conveniently located and easy to understand, ensuring optimal ergonomic support while seated.

### Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

### Allocation:

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. They represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on registered EPDs according to EN 15804, Ostfold Research databases, ecoinvent and other LCA databases. The data quality of the raw materials in A1 is presented in the table below.
